## Don's Moving & Storage Carrier Liability

You must select, in your own handwriting, on your bill of lading and order for service, one of the following three options for your shipment. The option you select establishes your mover's maximum liability for your goods subject to the

**Option 1:** Standard liability. Mover's maximum liability for any article that is lost, damage or destroyed while in your mover's custody is \$.30 (30 cents) per pound per article. All visible damage to house goods and any damages to containers must be listed on Bill of Lading or inventory at the time of delivery in order for any repairs, to be made.

**Option 2:** Depreciated liability in the event that the carrier's liability is not to 30 cents per pound per article. You may elect to purchase depreciated liability coverage in the event that any article is lost, damaged, or destroyed while in the mover's custody. Any payments made to repair the article would be based upon the current depreciated value of the article. The minimum amount allowed is \$2500.00. The charge for the coverage is \$.70 per \$100.00 you declare. All visible damage to household goods or containers must be listed on the Bill of Lading or inventory at the time of delivery in order for any repairs to be made.

**Option 3:** Full (Replacement) Value Protection. If any article is lost, damaged, or destroyed while in your mover's custody, your mover will either 1) repair the article to the extent necessary to restore it to the same condition as when it was received by your mover, or pay for the cost of such repairs; or if not repairable 2) replace the article with an article of like kind and quality, or pay you for the cost of such replacement. All visible damages to household goods or containers must be listed at the time of delivery on the inventory or Bill of Lading. The charges for this option are as follows:
